### ORDER

Vide paper read (1) above, the University had invited applications from the affiliated colleges for granting Continuation of Provisional Affiliation for the academic year 2024-25.

2. In response to the above notification, affiliated Medical Colleges had submitted their applications with required documents and remitted necessary fee.

3. The University had conducted inspection at these colleges and the reports of the inspection commission / subsequent compliance reports received from the institutions (wherever applicable) were scrutinized by the Scrutiny Committee. The Scrutiny Committee in its various meetings has recommended to grant Continuation of Provisional Affiliation to Medical Colleges for conducting Medical UG / PG courses with the intake mentioned against each shown in the tables below for the academic year 2024-25. Subsequently, the recommendations of the Scrutiny Committees were placed before the Governing Council meetings for consideration.

4. Vide paper read (4) above, the Governing Council has resolved to uphold the decision of the National Medical Commission in reducing MS Orthopaedics seats from 04 (four) to 03 (three) at MES Medical College, Malappuram for the AY 2024-25.

5. Vide paper read (2) (3) & (4) above, the Governing Council has resolved to grant Continuation of Provisional Affiliation to the following Medical Colleges for conducting medical UG & PG courses against the intake mentioned each for the AY 2024-25, after reduction of intake seats wherever applicable

6. As per the paper read (5) above, the Governing Council had decided that an affidavit incorporating a clause to the effect that if GST is imposed on the affiliation and other services by the authorities concerned, such GST and other dues including penalty if any will have to be borne by the affiliated institutions, shall be submitted to the university by the affiliated colleges.

9. The above colleges have not submitted the aforesaid affidavit in prescribed format to the University so far.

10. In the circumstances, orders are hereby issued granting **Conditional Continuation of Provisional Affiliation** to the above mentioned 12 Medical Colleges for conducting Medical UG and PG courses with the intake mentioned against each as shown in the above table for the academic year 2024-25.

11. **The Conditional Continuation of Provisional Affiliation now granted will be confirmed only on submission of an affidavit by the colleges with respect to levying of GST in the prescribed format within 3 months of the date of this order .**

12. As per the clause 2 (5) (ix) (16) of the Amendment of the 1st Statute on the matter of Affiliation of Colleges, *'if conditional affiliation is granted, conditions to be fulfilled and the time fixed for fulfilment of the conditions shall be specified in the order of the Governing Council granting affiliation. If the conditions are not fulfilled by the end of the period fixed, the affiliation shall cease automatically. If the conditions are fulfilled, the Governing Council shall have the power to confirm the affiliation at the end of the period'*

13. In addition to the above, the colleges shall strictly adhere to the conditions detailed below :-

i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

ii. In the light of the direction of the Hon'ble Supreme Court of India in writ petition (C) No.656/1998, the Institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

iii. Affiliation granted is strictly provisional and only for the academic year 2024-25. The colleges have to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with copy of the letter of approval from apex bodies concerned.

iv. The colleges should remit annual administration fee fixed for UG / PG courses for the academic year 2024-25, if applicable.

v. The College shall produce the orders regarding the constitution of College Council for the academic year 2024-25 during the time of student data verification.

vi. Admission to the next academic year shall be made only after obtaining prior permission from the University.
