Minutes of the Annual Meeting - IQAC Vision 2025: Reflection, Refine, Renew

The annual meeting of the **Internal Quality Assurance Cell (IQAC)** was convened on **5 August 2025 at 2:30 PM** in the **College Council Meeting Hall** under the theme "*IQAC Vision 2025 - Reflection, Refine, Renew.*"

The meeting began with a Welcome Address by Dr. Betsy Thomas, Principal & IQAC Chairman, highlighted the importance of aligning academic and administrative processes with national and international quality benchmarks, while also acknowledging the collective contributions of faculty, staff, and students in nurturing a culture of quality at Amala.

This was followed by an introductory address by Dr. Deepti Ramakrishnan, Vice Principal & IQAC Coordinator, who outlined the objectives of the session. She underscored the need to reflect on past achievements, refine institutional strategies, and renew commitments to quality. She also stressed the importance of reviewing progress across the criterias, identifying existing gaps, and finalizing the academic and operational plan for the year 2025-2026.

This was followed by structured, criteria-wise presentations and discussions, wherein each Criteria Head provided a comprehensive review of achievements, challenges, and future directions in their respective domains. The details of the presentations are as follows:



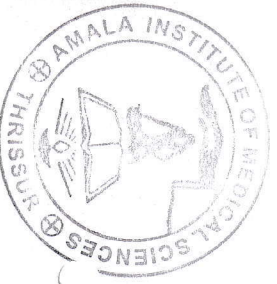

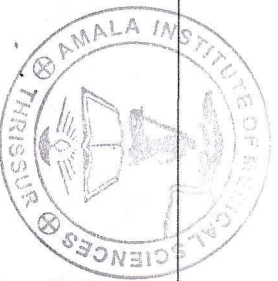

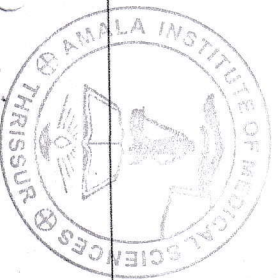

Closing Remarks & Recognition

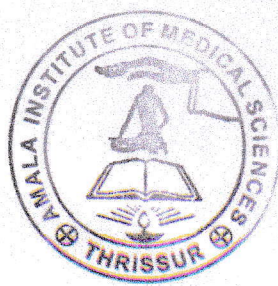
